I understand that this is a yearlong commitment to the VBHS Band and that all activities including rehearsals, performances, field trips, meetings, and other activities as listed on the official band calendar are mandatory unless the student is duly excused according to the official VBHS Band policy. I agree for my student to be photographed for approved school purposes.

I further understand that substantial funds and effort are being invested on behalf of my student's participation in the VBHS Band. In respect for this, I agree that my student will not drop the VBHS Band except under unique circumstances agreed to mutually by the VBHS Band Director(s) and Staff, student, and legal guardian. I understand that should my student drop the VBHS Band other than as stated, my student will be subject to referral to the school administration for appropriate consequences. Therefore, I pledge that my student will:

- ❖ Fully participate in the VBHS Band Program for the entire school year 2008-2009
- ❖ Attend all events and activities as posted on the official band calendar;

- ❖ Be present for the Pre – Camp – July 28 – August 1, 2008 (All Members)
- ❖ Be present for Band Camp (out of town) – August 3 - 8 (All Members)
- ❖ Be present for Post Camp Rehearsals (See Band Calendar)
- ❖ Be present and accountable for all posted Band Activities and Events as per the Official Band Calendar throughout the year (2008-09) including but not limited to the following specific dates...
